New & Used Unpainted-Unstained-Untreated Wood

\$ 35.00/Ton

This category is for loads that are all wood, including: Pallets, Wire Cable Spools, Untreated Poles, and Untreated Timbers, Plywood, Oriented Strand Board (OSB), Medium Density Fiberboard (MDF), Particleboard, Parallam™ OSL and similar products. This wood may include embedded metal such as nails or screws.

This category does not include wood that has been painted, stained or treated.

Co-Mingled Construction Debris and Shipping Crates

\$ 85.00/Ton

This category is for Co-Mingled loads from NEW construction job-sites. Typical construction waste such as: wood, steel, wire, aluminum, concrete and cardboard may be included in the load.

“Wood-Rich” Construction Debris Load, (80% Wood)

\$ 75.00/Ton

This category is for loads that are predominately clean wood, (80%).

Gypsum Wallboard

\$ 80.00/Ton

This category is for NEW gypsum scrap.

Carpet

\$ 70.00/Ton

This category is for **BROADLOOM CARPET & pad only**. No other flooring or construction debris should be included with carpet loads.

Concrete

\$ 65.00/Ton

This category is for Concrete, Rocks, Bricks and Asphalt Paving.

Demolition / Renovation Debris

\$ 85.00/Ton

This category is for Co-Mingled loads of wood debris from building demolition / renovation projects.

BEFORE LOADS WILL BE ACCEPTED: Documentation proving that an A.H.E.R.A. inspection was completed must be provided.

IF ASBESTOS CONTAINING MATERIALS WERE DISCOVERED: Documentation proving the asbestos containing materials were removed must be provided.

All mercury containing building materials must be removed such as but not limited to, thermostats, silent switches, float switches and fluorescent light tubes. Loads including mercury containing materials or evidence of mercury containing materials (broken lights) will be rejected.

Lead-Based Paint must be removed. We use XRF technology to detect lead in paint. If lead is detected, the load will not be accepted for recycle.

Land-Clearing Debris

\$ 50.00/Ton

This category consists of Stumps and Tree Limbs, whole or chipped.

Materials we will not accept:

Asbestos at any level, (Must be Non-Detectable)

Lead in Paint identified using XRF

Mercury Containing Devices

Medical Waste
